

Parking of Oversized Vehicles

- I. Prohibitions: No person shall park or leave standing upon any street, between 2 a.m. and 6 a.m., any of the following:
 - A. Any motorized vehicle, or combination of vehicle, extensions and attached trailers that exceeds any of the following criteria:
 1. Twenty (20) feet in length
 2. Seven (7) feet in width, exclusive of mirrors and safety equipment
 3. Seven (7) feet in height
 - B. Any non-motorized vehicle (including, but not limited to, a trailer, camper trailer, boat/watercraft trailer, farm machinery, construction equipment or other nonmotorized vehicle), regardless of length or width, when it has been detached from a motor vehicle.
 - C. SUVs and pickups less than 25 feet in length without attachments which are not commercial vehicles are exempted.
- II. The prohibitions described in subsection (I) of this section shall not apply to any vehicle that is:
 - A. Making pickups or deliveries of goods, wares, and merchandise from or to any building or structure located on the restricted streets or highways or for purpose of delivering materials to be used in the actual and bona fide repair, alteration, remodeling, or construction of any building or structure upon the restricted streets or highways for which a building permit has previously been obtained;
 - B. Parked or left standing as a result of a mechanical breakdown so as to allow the performance of emergency repairs on the vehicle for a period not to exceed twenty-four consecutive hours;
 1. "Emergency repairs" indicate the vehicle is not able to operate and therefore can not be moved other than by effecting said emergency repairs or having the vehicle towed.
 - C. Conspicuously displaying a valid, unexpired Oversized Vehicle Temporary Parking Permit and which is parked in a location authorized by this Chapter.
- III. Oversized Vehicle Temporary Parking Permits.
 - A. Vehicles displaying a valid, unexpired Oversized Vehicle Temporary Parking Permit (OVTPP) are only authorized to park along the curb line of the public roadway and adjacent to the block on which the permit applicant's address is located. If the applicant's address is located on a corner, then the permit

holder may park along the curb line of either of the streets adjacent to the block on which the permit applicant's address located.

- B. Except as expressly provided in this Chapter, an OVTPP does not authorize any vehicle to park in a location or manner otherwise prohibited by Lomita Municipal Code. An OVTPP does not authorize any vehicle to park in a location or manner otherwise prohibited by the California Vehicle Code.
- C. An OVTPP does not guarantee the availability of parking at any time and all applicants for OVTPPs proceed at their own risk with respect to the availability of parking. Once an OVTPP is issued, no applicant shall be entitled to a refund of any portion of the cost of the permit for any reason.
- D. Each OVTPP shall be valid for no more than three calendar days. OVTPPs are issued by the Community Services Department during regular business hours only. An OVTPP shall be effective beginning at 12:01 AM the day after the permit is issued. The form of the OVTPP shall be determined by the Community Services Director.
- E. All OVTPPs shall be conspicuously displayed from within the vehicle at all times when in use. The possession of a valid, unexpired OVTPP shall not be considered a defense to a citation for an illegally parked oversized vehicle unless the OVTPP was conspicuously displayed at the time of the citation.
- F. No OVTPP shall be issued to an applicant that has unpaid parking citations issued by the City of Lomita.
- G. No more than four OVTPPs may be issued in connection with a single household address in a calendar year, regardless of the name associated with the permit application.
- H. Any person who displays a counterfeit, forged, altered, or fraudulent OVTPP shall be guilty of a misdemeanor.
