NOTICE IS HEREBY GIVEN that the City of Lomita has vacancies on the following City Commissions/Boards and is accepting applications to fill the vacancies:

Public Safety and Traffic Commission. The Commission consists of five members appointed by the City Council and advises on traffic and public safety issues. The Commission makes recommendations to protect the public health, safety and welfare of all Lomita residents, promotes public safety events, and sponsors programs in cooperation with the local schools, the Los Angeles County Sheriff's Department and other agencies. The Commission meets at 6:00 PM on the fourth Tuesday of each month. Commissioners are appointed to four year terms.

Planning Commission. The Commission works with the Planning Division for the orderly growth of the community including preparation of the comprehensive General Plan. It holds hearings to consider various permit applications and submits recommendations to the City Council on such matters as amendments to the General Plan, Zoning Ordinance and tentative tract and parcel maps. The Commission consists of seven members and are appointed by City Council to serve four year terms. The Commission meets at 6:30 PM on the second Monday of each month.

Interviews may be conducted by the City Council to fill the terms. Lomita residency and voter registration is required to be considered. Interested citizens should complete a citizen resume form and return to City Hall.
