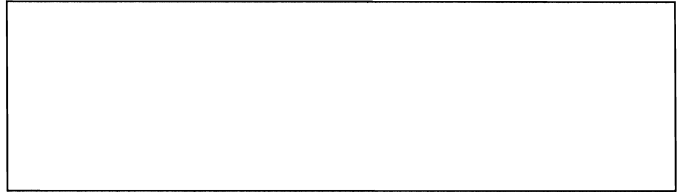

- * A maximum of two (2) Temporary Banner Permits may be issued for an individual site per calendar year.
- * Banners may be displayed no longer than sixty (60) consecutive days.
- * You must wait a minimum of thirty (30) days before you can apply for a second Temporary Banner Permit.
- * Temporary banners shall not exceed 32 square feet in size (24 square feet in the Downtown-Commercial Zone).
- * Banners shall be mounted on the wall of the building. They shall not be placed off-site or above the roof line.
- * All banners shall be aesthetically pleasing and shall be maintained in good condition at all times.
- * Failure to remove the temporary sign after expiration of the permit and failure to maintain the sign in good condition will result in the city causing the sign to be abated subject to section 1-2.01 of the Lomita Municipal Code.
