City receives grant for smog-free electric vehicles

Lomita, known as the “friendly” city, is also environmentally friendly. Two Global Electric Motorcars (GEMs) have been purchased using grant funds provided by the South Coast Air Quality Management District from fees collected by the Department of Motor Vehicles (\$8,700 for both GEMs). These vehicles are bubble shaped and seat four passengers. Since they run on electricity, no smog or other toxic emissions are produced. The vehicle can achieve speeds of up to 25 mph and is legal on streets posted up to 35 mph.

One of the cars will be used by city personnel at the Parks Department, the other one at City Hall. To recharge, the vehicles must be plugged into a standard socket overnight.

Remodeling your home or office?



Please don't make the mistake of not checking with the Planning and Building departments when you hire a contractor to do some work on your house or place of business! Some home repairs like new roofing, water heaters, or windows seem like minor items. However, these and many other building-related items are regulated by the building code and require inspection by the building department.

The State law requires disclosure about real property at the time of sale, including building permit records. Because of this, buyers are more likely to ask for information about permits for remodeling and upgrades in a home.

Not only is it embarrassing, but it is also troublesome to speed through the building permit and inspection process when you are trying to close escrow. The proper time to apply for a building permit is **before** construction starts. In the worst cases where the contractor is unfamiliar with the local codes, the homeowner might have to demolish and rebuild an unpermitted structure or addition. Unfortunately, there are even a few contractors who will say they obtained permits but in fact did not.

For your peace of mind, call the City about your remodeling projects and obtain copies of the building permits for your own records. When you eventually sell your property, a complete building record might save you heartache and stress.

Arbor Day and "Looking Good Lomita" Celebration

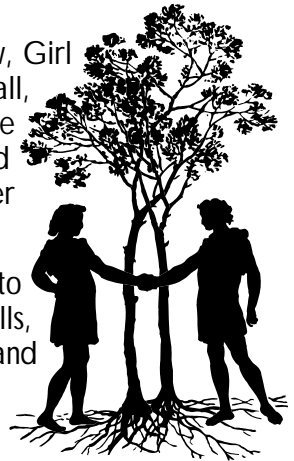
This year's Arbor Day and "Looking Good Lomita" celebration is planned for Saturday April 26, 2003.

Beware of telemarketing scams that ask for your social security number, PIN Number, bank account, credit card, etc. Personal information given out over the telephone can be used fraudulently to open accounts in your name which you may be liable for.

Incidences of identity theft and telemarketing scams have increased in the past. Often the targets of unscrupulous operators are senior citizens.

Not all telemarketing companies operate legitimately. Do not give out personal information, unless you know who you are talking to and you have originated the telephone call.

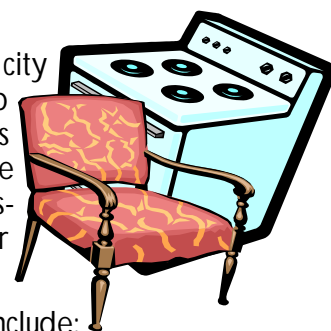

Large Item Pickup

During the week of April 7, the city will hold a large item pickup for all its residential customers of 5 units or less. Please place the items you would like to dispose of on the curb on your regular trash pickup day.



Items that will be collected include: household appliances, furniture, carpets, mattresses, white goods, tree trunks and other oversized yard waste that is not larger than two feet in diameter and four feet in length.

Additional large item pickups for a fee may be requested by calling CALMET at 212-3496. They will usually respond within three days.

Seniors needing help getting items to the curb should contact the Field Services Department at 325-9830.

You asked:

"What can I put in the blue barrel?"

GLASS: Clear and colored bottles and jars

PLASTIC: Milk, soda, juice, water and soap containers (#1PET and #2 HDPE)

METAL: Aluminum cans, metal food cans, coat hangers, foil and empty aerosol containers

PAPER: Newspaper, cardboard, magazines, envelopes, junk mail, white and colored paper, computer paper, cereal and tissue boxes, egg cartons, shopping bags, and non-metallic wrapping paper

Styrofoam articles cannot be recycled and must be placed in the regular trash.

Annual Tree Maintenance Report

The City of Lomita and West Coast Arborists have been working together for over three years. Systematic tree maintenance reduces the long term expenses of the urban forest while maintaining the financial value of one of Lomita's most valuable assets: trees. In the past fiscal year, West Coast Arborists has



- ◆ pruned 917 trees
- ◆ removed 17 trees
- ◆ planted 104 trees

The number one species pruned was the Canary Island Pine, a evergreen tree that flourishes in full sun with little water. It is a fast growing tree with a graceful, pyramid appearance. It can reach 60—80 feet in height. Brazilian Pepper, London Pine and Ornamental Pear follow the Canary Island Pine in the list of top species.

Beetle Endangers Pine Trees

In recent months, city staff removed several pine trees infested by a Western Pine Beetle. After killing one tree, the Western Pine Beetle moves onto the next.



If any pine trees are located on or near your property, please examine them carefully. Signs of a beetle infestation are

- ◆ Excessive sap
- ◆ Boreholes
- ◆ Tree is losing its color and turning brown starting at the tips of the branches.

If you notice any of these tell-tale signs, please contact the Field Services Office at 325-9830. Any information you provide may help us contain this pest.

Your vigilance and cooperation can stop the infestation and save our precious pine trees.
